Terms & Conditions

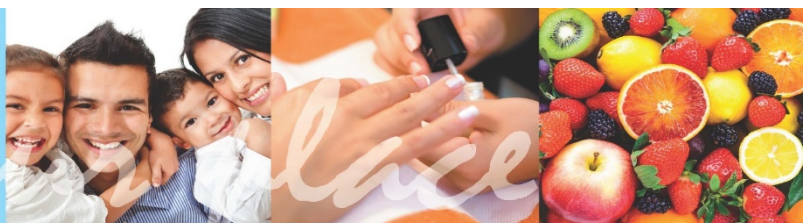
1. These official rules ("**Rules**") apply to the "**Christmas Giveaway**" promotion ("**Promotion**") conducted by the Promoter for Logan Central Plaza ("**Centre**").
2. Information on how to enter forms part of these Rules. The Promoter may, at any time, amend, add to or delete any of these Rules.
3. Entry is deemed acceptance of these Rules including any changes made by the Promoter, even if the entry is before the publication of any changes to these Rules.
4. The Promotion commences at 7:00 am on Monday 3rd December 2018 and ends at 9.00pm Friday 14th December 2018 ("**Promotion Period**").

Eligibility


5. To be eligible to enter the Promotion an individual must:
 - (a) be at least 18 years of age;
 - (b) be a resident of Queensland; and
 - (c) make an Eligible Transaction:
6. An "Eligible Transaction" is a purchase:
 - (a) of any goods or services purchased from a Participating Retailer at Logan Central Plaza;
 - (b) valued at \$15.00 or more at a Specialty Retailer or \$50 from Coles and/or Kmart, in one transaction;
 - (c) during the Promotion Period;

An "Eligible Transaction" does not include:

- (i) gift vouchers; or
- (ii) payments for rates, gas, electricity, telephone accounts, vehicle registration, subscriptions to health fund and/or ambulance subscription;
- (iii) deposits into banks, building societies or other financial institutions or payments on account of insurances and the like; or
- (iv) telephone, internet or mobile phone calling cards or credit vouchers;
- (v) lay-by payments deposits or finalisation of lay-by.

7. A “Participating Retailer” means any retailer in Logan Central Plaza only.
 8. The Promoter, Retail First Pty Ltd, retailers of the Centre and their respective officeholders, employees, agents, contractors, and their immediate families (including those living with such officeholders, employees, agents, and contractors) are not eligible to enter the Promotion.
 9. Despite Rule 5(b), an individual who is not a resident of Queensland is eligible to enter the Promotion if he or she will be a resident of Queensland at the time the Prize is drawn.
 10. An Eligible Transaction must be evidenced by an original official store receipt from a Participating Retailer that is clearly marked with the date of purchase, the amount of the purchase and the store trading name (“**Valid Receipt**”), and the Valid Receipt must be securely attached to the entry form.
 11. An individual who enters the Promotion (“**Entrant**”) may enter the Promotion as many times as he or she wishes, provided these Rules are complied with.

Obtaining an Entry Form

12. During the Promotion Period, Entrants will be entitled to one official entry form (“Entry Form”) for each Eligible Transaction.
13. To obtain an Entry Form, Entrants must request their Entry Form from the Participating Retailer or visit Centre Management with receipt.
14. Participating Retailers have the right to refuse to provide an Entry Form if the Entrant has not spent the minimum amount to receive an Entry Form.
15. The maximum number of Entry Forms that an Entrant may receive for a Valid Receipt is one.
16. To obtain an Entry Form, Entrants need to spend an amount of \$15.00 or more at a Specialty Retailer or \$50 from Coles and/or Kmart, in one transaction. Entrants cannot combine receipts from a Retailer/s to obtain an Entry Form.

Lodging an Entry Form

17. To enter the Promotion, Entrants must lodge completed Entry Forms in the Promoter’s official entry barrel or similar device (“**Entry Barrel**”) located outside Coles, during the Promotion Period.

18. To be a valid entry (“Valid Entry”):
- (a) the entry must be on an original official Entry Form issued during the Promotion Period by a Participating Retailer, or from Centre Management – photocopies will not be eligible to win the Promotion;
 - (b) the Entrant’s name, telephone number and address on the Entry Form must be complete and legible; and
 - (c) the Entrant must be eligible to enter the Promotion (see Rule 5);
 - (d) the Entry Form must have the Valid Receipt securely attached to the Entry Form.

Prizes

19. The total available prize pool for the Promotion is \$3600.00 comprised of:

- 20. The Prize is not transferrable or exchangeable for any other goods or services and cannot be taken as cash.
- 21. Coles gift card cannot be used for tobacco.
- 22. The Promoter accepts no responsibility if a winner of a Prize does not use the vouchers comprising the Prize before the expiry date. The Promoter will not exchange an expired voucher with a replacement voucher, or any other goods or service and the value of the expired voucher cannot be taken as cash.
- 23. Use of the vouchers comprising the Prize is subject to any terms and conditions imposed by the retailers in respect of the voucher/s issued by those entities.
- 24. Complete value must be used in one transaction.

Drawing of Prizes

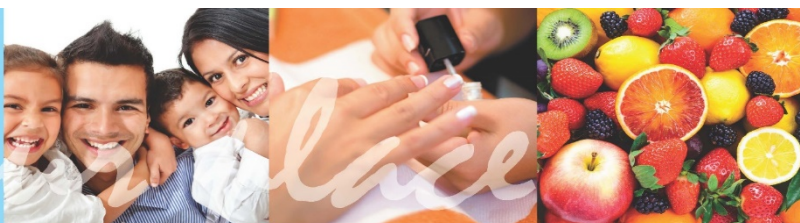
- 25. The drawing the Prizes (each being a “Draw”) will take place in the Promoter’s office in the Centre (“Centre Management Office”).
- 26. Each day a draw will take place starting on Tuesday 4th December until Monday 17th December 2018. Weekend draw will take place the Monday following the weekend.

27. The person whose name appears on the first Valid Entry randomly drawn will win the Prize for that Draw (“Winner”).
 28. If an Entry Form has two or more individuals names recorded as the entrant, the Winner will be the name of the individual whose name appears first on the Valid Entry drawn.
 29. The results of the Promotion may be published and the Promoter reserves the right to publish the details of the winner.
 30. To be able to collect the Prize, a Winner must (if required by the Promoter) provide a copy of a Government issued identification card containing a photograph of the Winner as proof of the Winner’s identity, age and place of residence.
 31. The Prize does not include delivery. The Winner is responsible for collecting the Prize from the Centre Management Office at Logan Central Plaza.
 32. If the Prize is unclaimed it will be dealt with as directed by the Queensland Office of Gaming Regulation in accordance with the Charitable and Non-Profit Gaming Act 1999.

General

33. The “Promoter” is Trondage Enterprises Pty Ltd ACN 067 120 370 of c/- Retail First Pty Ltd, 38-74 Wembley Road, Logan Central in the State of Queensland, trading as Logan Central Plaza.
34. In the event of war, terrorism, state of emergency or disaster, the Promoter reserves the right (subject to all relevant State and Federal laws), to cancel, terminate, modify or suspend the Promotion.
35. The Promoter’s decision in respect of all aspects of the Promotion is final and binding on all Entrants and no correspondence will be entered into.
36. The Promoter will not be liable for any loss (including, without limitation, indirect or consequential loss), damage, personal injury or death which is suffered (including but not limited to that arising from any person’s negligence) in connection with the Promotion and/or any aspect of the Prize, except any liability that cannot be excluded by law (in which case that liability is limited to the minimum allowable by law).

All Entrants are responsible for any taxation liability (including any GST) or other government charges or reporting requirements arising from their participation in the Promotion or receipt of the Prize (if any). If participation in the Promotion or receipt of the Prize involves a taxable supply being made, then the Entrant is responsible for paying any amount charged by the entity making the supply in respect of its GST

By entering an email into the Logan Central Plaza website sign-up page and confirming with the automated sign-up email or by depositing a Valid Entry in the Entry Barrel, all Entrants consent to their personal information being entered onto a database, which may be made available to the Promoter for marketing purposes relating to the promotion of the Centre and retailers located in the Centre.
40. All Entrants agree to have their name and photograph used for advertising purposes and/or to take part in promotional activities including, without limitation, being interviewed by television, radio and/or other mediums for public broadcast.
41. The Promoter reserves the rights, trademarks and copyrights of the Promotion and all artwork, images and print copy associated with the Promotion.
