

Mother's Day Gift with Purchase 2021 – Crystal Bracelet Terms & Conditions

1. The Mother's Day GWP promotion commences at 8.30am on Tuesday 4th May 2021 and ends at 5.30pm on Friday 7th May 2021 (while stocks last), this will be referred to as the 'Promotion Period'.
2. Customers must spend a minimum of \$20.00 in any participating specialty Retailer at Logan Central Plaza, 38-74 Wembley Road, Logan Central Plaza, Logan Central ("Centre") during the Promotion Period.
3. Customer must present the original receipt to Centre Management, level 2, Logan Central Plaza to receive one (1) FREE 'Crystal Bracelet' while stocks last.
4. Gift with purchase can only be collected during Centre Management office opening hours, (Monday – Friday 8.30am - 5.30pm).
5. Bracelets are limited to one (1) per person, per day.
6. Each original receipt presented will be marked upon presentation, and that receipt cannot be used again.
7. The minimum \$20.00 spend must be spent in a single transaction and cannot be made up of more than one receipt.
8. Each day there is 100 'Crystal Bracelets' available with a total of 400 'Crystal Bracelets' available to be claimed with proof of purchase during the Promotional Period.
9. Purchases from participating retailers must be made during the above-mentioned Promotion Period, and the receipt must be presented to Centre Management before stocks run out. There will be no exceptions should customers try to present receipts after the promotion period, or while stocks last.
10. To be eligible a shopper must make an "Eligible Purchase".
11. An "Eligible Purchase" is a purchase:
 - of any goods or services over \$20.00 in one transaction from any participating Logan Central Plaza store from 8.30am on Tuesday 4th May 2021 and ends on Friday 7th May 2021.
12. An "Eligible Purchase" does not include the following:
 - i. Tobacco or alcoholic products;
 - ii. Gift Cards;
 - iii. Payments for rates, gas, electricity, telephone accounts, vehicle registrations, subscriptions to health funds or the ambulance;
 - iv. Deposits into banks, building societies or other financial institutions or payments on account of insurances and the like;
 - v. Payments or purchases of prescription drugs or medicine from Chempro Chemist;
 - vi. Payment or purchases of Gold Lotto or Scratch products from Logan Central News Extra;
 - vii. Layby or instalment payments (other than the first layby or instalment payment) bill payments;
13. The participating Logan Central Plaza retailers include specialty retailers only that provide a valid receipt. This promotion does not include purchases from Coles and Kmart.
14. Owners and employees (Retailers) and their respective families, of the centre are ineligible to participate in this promotion.
